Village Council Proceedings February 6, 2012

Regular meeting was called to order by President Kilty at 6:30 P.M.

Roll Call: Trustees Frome, Gilbert, Hagen, Maurer, Pokallus, and Staples were present.

Proposals were opened for carpeting in the Library:

Motion by Frome, seconded by Pokallus was carried to have the Parks and Buildings Committee review and bring back a decision at the next meeting.

Motion by Pokalllus, seconded by Gilbert was carried to approve the minutes as read.

Leon Pankratz and Randy Kaiser from 1002 and 404 South Pacific Street discussed with the board in regards to cleaning the snow off the sidewalk and would like to see the Village continue to clean the sidewalks of snow this winter.

Gene Allar from 1107 South LaSalle Street questioned why the property owners should not be cleaning their sidewalks as most everyone else has done for years. Allar has customers along Highway 13 and would like to continue cleaning those walks.

Travis Holt from 302 South Pacific Street concerned with semi-trailers parked near Highway 13 and would like to see all semi-trailers removed from Commercial zoned land that are being used for storage. The matter was turned over to the Economic Development committee for review.

Motion by Frome, seconded by Gilbert was carried to approve an application for a Class "A" Beer and Liquor license for Hansen's IGA Inc. at 1110 South Pacific Street.

Applications were read for a Class "A" Beer and Liquor license for 208 South Pacific Street and for 1110 South Pacific Street.

Motion by Hagen, seconded by Pokallus was carried to table discussion on sign regulation 13-1-121 until next meeting.

Motion by Hagen, seconded by Frome was carried on unanimous roll call vote to approve invoices totaling \$86,532.37.
