Regular meeting was called to order by President Kilty at 6:30 P.M.

Roll Call:

(Hagen)(Maurer) was carried to dispense the reading of the previous meeting minutes and approve them as printed

Public Works Report:

Dean Smith spoke about an underground water leakage that occurred within the 100 block of East Clark Street

Dean also reported on two water main breaks on North Chestnut Street, a valve box leak near the saw shop and a valve box break on North Pearl Street

(a). (Hagen)(Pokallus) was carried to approve sending Thad Kubisiak for a budget and finance workshop in Wausau on Sept. 18, 2013

- (b). (Frome)(Hagen) was carried on a unanimous roll call vote to approve <u>RESOLUTION</u> <u>2013-07</u> Resolution recommending the approval of project plan and creation of mixed use tax incremental finance district no. 3
- (c). (Frome)(Maurer) was carried to confirm the Village President's appointments to the Deer Hunt Task Force as per Section 11-2-16 of the Village of Spencer Code. The Deer Hunt Task Force members are Al Bauer, Dale Mros, Roger Shupe, Jim Kilty, Greg Pokallus and Dianne Gilbert
