(a) (Hagen)(Pokallus) was carried to authorize Dean Smith to go to an annual WRWA outdoor expo, on August 20th, for a cost of \$65.00

- (b) (Pokallus)(Hagen) was carried to approve "Operator's" licenses for Emilee Weisgerber (Nutz Deep) and Lynn Oliver (Kwik Trip)
- (c) (Hagen)(Schafer) was carried to approve the sewer rates presented by Chris Helgestad which will result in an overall rate decrease to residents
- (d) (Schafer)(Pokallus) was carried to approve Change Order #1, from Anderson Electric for a unit price increase of \$4,678.64, for added street lights to the LED Street Light project
- (e) (Hagen)(Day) was carried to recommend applying both layers of blacktop west from the LaSalle Street intersection until the west lot line of the Guzinski Trucking building and apply only the binder layer west from that point to the West Willow Drive project limits
