President Frome sent this matter to committee

Public Works' Report:

John Dunbar reported that he received some literature from Reesterer and Schnell. John mentioned that the first layer of asphalt has been placed on the roadway for W Willow Drive Project

President's Report:

President Frome mentioned that there is a complimentary Ruder Ware legal seminar. She also highlighted discussions from the Fire and Ambulance Commission meeting

- (i) (Hagen)(Schafer) was carried to approve Village Clerk to publish a job posting for the position of Administrator/Clerk/Treasurer
- (j) Becky Gorst presented the concept of a new organization taking over the adult softball league at the ARC Park facility. Becky also mentioned that she thought that the park could be renamed in honor of Lorren and Bettye Nall. Becky reported that she has approx. 15 individuals who have pledged support for this venture. Carolyn Bauer mentioned that she is willing to help with any transitional hurdles

- (k) (Schafer)(Hagen) was carried on a unanimous roll call vote to approve vouchers totaling \$115,673.20

Clerk's Report:

- (a) Building permit issued to Tod Hewuse, located at 1102 E Aspen Street, for repairs to the front of the house, at an estimated value of \$5,500.00
- (b) Building permit issued to Jerry Marden, located at 104 N Monroe Street, for a garage addition, at an estimated value of \$17,000.00

- (c) Driveway permit issued to Joe Ruger, located at 303 W Buse Street, at an estimated value of \$3,000.00
- (d) Building permit issued to Jim Zahn, located at 700 W Clark Street, for floor replacement, at an estimated value of \$4,000.00

Committee Reports:

- (a) Finance and Personnel Committee Chairperson Hagen reported on the progress of the personnel handbook, as well as employee return-to-work policy. A new organizational structure, that includes a police commission, was discussed
- (b) Utilities and Equipment Committee Chairperson Schafer spoke about the previous committee meeting. Decommissioning the small water tower was discussed as well as locating a potential well #7 well site. Chairperson Schafer also reported on an equipment replacement plan
- (c) Parks and Buildings Committee Chairperson Toufar mentioned that there are two locations where the ceiling tiles are wet within the Historical Society. Public Works will look into the matter. President Frome reported that the tech-ed teacher at the high school may be interested in the proposal to have his class build the ramps for the skateboard concrete area
- (d) Health, Safety and Emergency Gov't. Chairperson Toufar had nothing to report
- (e) Economic Development and Main Street Thaddeus reported on a prospective out of town manufacturing business, which Emily Matchey will contact for relocation within the business park
- (f) Streets and Sidewalks Chairperson Day mentioned that he will look into the matter for the driveway apron at 711 W. Roberts Street, as well as the asphalt that was removed on South Washington Street
