# **Minutes of Regular Board of Trustees Meeting**

## Monday, January 8th, 2018 - 6:30 P.M.

### **Spencer Municipal Complex**

President Frome called the meeting to order at 6:30 P.M.

The Pledge of Allegiance was recited.

<u>Roll Call</u> Trustees Hoes, Hagen, Carolfi, Schafer, Wienke, and Toufar were present.

Approval of Minutes

(Schafer)(Toufar) was carried to dispense with the reading of the previous meeting minutes and approve them as printed.

<u>Public Comments</u> There were no public comments.

#### Public Works' Report

Paul Hensch reported on a water main break on East Willow. He continued to report that John Dunbar, Chris Helgestad and himself met with MSA to go over the N LaSalle Project. He anticipates that bidding for the project will be held in early February. Finally he reported that Chris and he met with the DNR and McMahon to go over the finances for the Wastewater Treatment Plant modifications. He anticipates that loan to close on March 28<sup>th</sup>.

#### Police Chief's Report

Chief Bauer reported that, in December, officers handled 122 calls for service, issued 25 traffic citations, 3 Municipal citations, and 16 written warnings. The department investigated 3 traffic accidents and made a total of 9 arrests.
