Village of Spencer Minutes of Regular Board of Trustees Meeting Monday, May 10, 2021 – 6:30 P.M. Spencer Municipal Complex

President Toufar called the meeting to order at 6:30 pm.

Roll Call

Approval of Minutes

(Carolfi)(Krause) was carried to dispense with the reading of the previous Regular Board of Trustees meeting minutes and approve them as printed.

Public Comments

Dan Hill and Todd Hewuse asked about paving Willow, Aspen, and Apple streets. It was noted that Aspen Street and Apple Street would be getting pavement this year. Todd asked about curb and gutter due to the draining issues along Aspen Street. Paul Hensch mentioned that ditch and culverts were the responsibility of the homeowners. The Village will look into the problem.

Public Works' Report

Paul reported that all streets in the Village have been swept. He mentioned that the Village's strategy at the WWTP to reduce ammonia coming in from the haulers has been working great. We have increased the interval between pumpings to allow haulers to bring in waste from customers that pump every 14 weeks compared to 12. If ammonia remains low, we will have another increase in that interval.

Police Chief's Report

Chief Bauer reported that, during the month of April, officers handled 170 calls for service, issued 23 citations, and 65 warnings.
