Approval of Minutes

Public Works' Report

Paul Hensch reported that the Village has been awarded 2 large grants. The first is for \$1.5 million for the construction of well number 7 and the second is for \$450,000 to resurface E Willow Drive between Park St and Monroe St in 2024. Ethan and Chris have completed the yearly sewer line jetting. They cleaned 21,000 feet or 27% of the lines. Paul finished by reporting that the cameras that were installed at the compost site have caught our first person illegally dumping. The issue was referred to the police department.

Police Chief's Report

Chief Bauer reported that, during the month of September, officers handled 175 calls for service, issued 21 citations and no warnings.
